#### II. Restoration Society

Arne Goldman spoke about the old (1900s) Cleveland School Style and how neighborhoods in Cleveland formed around the schools. Arne spoke about the high level of home ownership around Longfellow. He said the neighborhood around Longfellow cares about its community. In return, everyone benefits, including the school, the local neighborhood, the residents. The neighborhood has made a massive change for the better. Longfellow is an example of the public and private sectors working together. A 28-million-dollar redevelopment effort. Instead of using the money to tear down the building, the school district used the money to redevelop it.

#### **III.** Tour of The Longfellow

The Commission toured the apartments and saw a brand-new senior living community for adults 62 and older. The Longfellow features new one- and two-bedroom apartment homes, wellness rooms and a gymnasium-turned-fitness center. The apartment building has the original book cubbies refurbished into wardrobes, restored wood flooring, and the original classroom doors.

David Riley said a developer is working on developing Robert Fulton on his own. David Riley said Seltzer would become a little league football field and parking lot for the field and Cudell Rec center.

#### - Commissioner Schuster asked about Lincoln-West High School

David Riley said that the development got held up, but the district plans to fill in the concrete hole under the building and add a soccer field to the school.
